- **Cancellation and Rescheduling:** One-time opportunity to reschedule with a deposit transfer with 48-hour notice. Cancellation and rescheduling with less notice will result in a forfeit of your deposit. If the photographer must cancel for any reason, a refund or transfer of the deposit to a new agreed-upon date will be initiated.

3. USAGE RIGHTS

- **Photographer's Rights:** The Photographer retains full copyright and irrevocable rights to use images for portfolio, marketing, and promotional purposes.
- **Client's Rights:** The Client is granted a non-exclusive license for personal use (social media and prints). Commercial use requires written consent.

4. PHOTO & VIDEO RELEASE

- The Client grants the Photographer permission to capture and use images/videos of the Client and event attendees for any lawful purpose, including promotional use. The Client waives any claims related to privacy or defamation. The Photographer agrees to not use any photos or videos to intentionally harm, embarrass, expose, or otherwise misrepresent the client.

6. MODEL RELEASE

The Client agrees and has granted permission for their likeness to be used by the Photographer in accordance with this agreement. The Client assumes full responsibility for obtaining any necessary releases from other individuals at the event.

7. LIMITED LIABILITY

- The Photographer will take all necessary measures to ensure the quality of the images but cannot guarantee specific results due to uncontrollable conditions (e.g., weather, lighting).
- In the event that the Photographer is unable to perform due to illness, emergency, or unforeseen circumstances, the Photographer will refund any payments made by the Client in full.

8. GOVERNING LAW

This agreement is governed by the laws of New York City, NY.. Any modifications must be in writing and signed by both parties.
